### **Selection**

A committee appointed by the Willamette Valley Agriculture Association Board of Directors shall serve as the selection committee for the scholarship.

The WVAA does not discriminate for or against any person on the basis of ethnicity, nationality, place of origin, religion, race, gender, sexual orientation, marital status, familial status, family relationships, economic status, age, or mental or physical disability.

### **Awarding and reporting**

Scholarship funds shall be paid directly to the schools. Arrangements shall be made by recipient with schools for reporting back to the WVAA on enrollment of recipient and appropriate use of funds. WVAA shall closely monitor the distribution and use of scholarship funds and investigate any possible misuse. WVAA will withhold funding if impropriety is found or suspected and seek recovery of any misused funds.

### **Confidentiality**

It is the policy of the Willamette Valley Agriculture Association that all documents and information provided to the WVAA for scholarship consideration shall be used solely for determining recipients. All application materials are confidential and shall be used only during the selection process, and for no other purpose. Application materials shall be held by WVAA for a reasonable time and then destroyed.

### **Amount of funding**

The WVAA Board of Directors shall determine the amount of scholarship funds, the total number of awards to be given and at what frequency in the first quarter of each calendar year as part of its normal budget process. The board may at its discretion determine that there are no funds available in any given year and decide to conclude the scholarship or suspend it. Funding for scholarship is derived from proceeds of the Willamette Valley Ag Expo in November, donors and fundraisers and as such is subject to change.

### **Student responsibility to attend**

The annual event produced by the WVAA takes place in November in Albany. The board of directors requires recipient participation at the special function on Wednesday evening to assist with promotion of the scholarship program. The board understands there may be travel costs for some students and will reimburse on a case by case basis. Attendance at the event would include meeting the public and helping to promote the scholarship through active communication, handing out materials, answering questions and assisting with the event when possible. Arrangements for student participation will be made individually through the staff for the WVAA by the students.
